EMPLOYMENT

It evolved into a consulting company providing full scope services for attorneys, sureties, and insurance companies as well as private contractors and developers. Consulted in a two-year fulltime assignment with subsidiary of Zurich NA in prevention of defaults, monthly progress reviews and takeover of defaulted projects. Experience in case work with attorneys includes investigation of construction accidents and defects, and providing expert testimony. Provide assistance in arbitration negotiations and litigation. JSCPM has provided inspection and project management of major municipal projects and hospital construction including interior work, upgrading for energy requirements, and pre-construction for expansion. Provided supervision and project management for completion of a multimillion dollar school project. Provided management and inspection services to municipalities on underground construction projects.

Vice President/Land Development and Construction, W.W. Dean and Associates, 1987-1992

Construction Manager for a project on an undeveloped section on the west side of Mt. San Bruno in South San Francisco. This project was a 790 acre planned commercial and residential development on this hillside area of South San Francisco. This project included phase two residential dwellings. Managed \$85 million dollars of required site work and retaining walls on this hillside project that included single family and multifamily attached structures for 500 residential units, a complete fire station, school play field, all required underground storm and sanitary drainage. This project also included five miles of expressway, dry utilities for all underground electrical work, and complete private street improvements. This demanding project, adjacent to San Francisco Bay, required the interaction with seven Federal agencies and involved demanding environmental issues. This project was a large regional project and one of great environmental concern due to its location and visibility to the public.

Vice President-Design and Construction Arroyo Development Corporation, 1982-1987

Joined this land and commercial business park developer as a principal, director, and Vice President. In charge of the design and construction for all projects. Project director of work in Hawaii. Responsible for the planning and preconstruction, and assistance with acquisition of funding followed by the construction of commercial buildings including tenant improvements, and infrastructure for a 180 acre high tech business park, and two other smaller similar projects. Arroyo also involved in the task of obtaining State Land Use development permit for a 300 acre development in Maui. This was the first project that allowed fee-simple development in Hawaii.

Project Manager and Business Development, Nicholson-Wilson Corporation, 1981-1982

This company had merged with a partner, and then was purchased by with ABV Construction Company of Sweden. Contributed to business development strategy and managed construction of a hillside condominium project in San Francisco. Concurrently involved with restoration work of historic buildings at University of Santa Clara.
